1) Organization and Nature of Operations

2) Significant Accounting Policies:

Use of Estimates:

The financial statements are prepared in conformity with Tax Basis of accounting principles generally accepted in the USA. The management uses estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the balance sheet and the reported amounts of revenues and expenses during the reporting period. For the purpose of reporting, The Company considers all highly liquid investments with maturity of three months or less to be cash equivalents.
